#### **Background**

Following the Ailuk Working Group Consultation on 6<sup>th</sup> June 2018, the feedback from the Senator, Mayor and Councillors, as well as from other participants was analysed and an activities and budget matrix was prepared for the RENI activities in RMI. The main objective of this overall consultation was to present key components of the RENI project to a wider audience of partners and obtain their endorsement of the activities matrix.

#### Logistics

The RENI project supported the travel and stay of the Ailuk Mayor and Councillors to Majuro for this consultation. The agenda is presented in Annex 1. Twenty one persons participated in the consultation (4 were female and 17 were male). The list of participants is presented in Annex 2. Besides government agencies, non-government partner agencies included the International Organization for Migration (IOM), Marshall Islands Organic Farmers Association (MIOFA), Taiwan Technical Mission and the Red Cross. Marshallese was the main language of the consultation with some translation into English.

#### **Opening**

The meeting was opened by the Chief Secretary, Mr Ben Graham.

He noted the importance of the RENI project and that although the project is not a huge one, the knowledge gained about food security for the RMI will be very important. RENI is essentially a learning project for the RMI. There are several ongoing and pipeline projects dealing with water security but fewer focusing on food security. The two atolls were carefully selected, Ailuk being a very remote, rural atoll, while Santo-Kwajalein is a semi urban atoll.

Referring to the discussions among the Ailuk community on the previous day about their RO plants being out of commission and needing repair, he proposed getting the assistance of a technician from Ebeye to assist with repair and maintenance.

He also mentioned that the government is presently preparing the budget for 2019 and that there was the possibility of helping the atolls with specific items relating to RENI and food security.

#### **Presentations and Discussion**

The participants viewed the video "Experiences and lessons learnt in the 2013 & 2016 droughts in Marshall Islands".

Kathryn Relang, SPC-Regional Rights Resource Team Focal Point for RMI, then gave a presentation on applying a gender sensitive and rights based approach in the RENI project, which was well received. She emphasised particularly that a rights-based approach is not **what** you do in your project, rather it is about **how** you do your project.

Following this, Poasa Nauluvula, SPC Land and Resources Division, recapped the activities that were planned for Ailuk, based on the previous day's consultation. Among the discussion points were the following:

- The Taiwan Technical Mission offered their support to the project. They have a supply of seedlings that can be provided free to the outer atolls.
- It was recommended not to use chemical fertilizers in the outer atolls.
- It is proposed to introduce yams because they do well on the drier islands of Fiji and Tonga and they can be kept for a few months.
- Open pollinated seed varieties will be used for home gardening and training will be provided on how to store the seeds.
- MIOFA offered to help with introducing different livestock breeds that can be inbred with the local breeds.

Gillian Cambers, RENI Project Manager, then gave an overview of the matrix of activities and budget allocations for the RENI activities. The discussion included the following:

- The RENI project model can be used for other projects. The Catholic Church is preparing a proposal to address climate change in the islands where there is a Catholic Church. Churches are often used as emergency shelters.
- Soil improvement and technical experience with soil pH is critical for the RENI project SPC Land and Resources Division has experience in this area.

The matrix as presented and agreed on here will now be developed into a Project Design Document and a draft will be sent to Government for review in the coming days.

In his closing remarks, Timmy Langrine, Director of the National Disaster Management Office, thanked the Ailuk community and all the participants on behalf of the Chief Secretary's Office. He also urged the Ailuk Mayor to send in any proposals to the Chief Secretary's Office, as had been mentioned in the opening remarks.

A short evaluation was conducted, which showed the participants were highly satisfied with the Consultation. One participant noted: "The RENI project seems to be a project delivering on a sustainable approach, (evident) through the project planning and design."
